- 4. Lead and support the program team to implement M&E Strategy, the key components of which may include: impact evaluation, research, beneficiary feedback, online database (monitoring system) and verification.
- 5. Review all program documentation to ensure they meet the required quality and ensure compilation and sharing of timely and quality reports.
- 6. Support and plan the process to form networks with various stakeholders such as development sector donors, Government bodies, NGOs, private sector, research organizations and academic institutions to take forward the Foundation research strategies.
- 7. Lead and foster the culture of research, analysis and learning within the country team.
- 8. Keep the track of emerging issues / risks (related to health that potentially impact eye health work) and work with the program team to identify options and prepare them for any possible risk(s).
