Remuneration package

Purpose of the role:

The **Program Manager** is accountable for the planning, design, and operational delivery of the FHF “Community Eye Health Project “(CEHP) & other assigned projects in the Philippines, in alignment with The Foundation’s strategic framework and the FHF Philippines country strategy.

The Program Manager will own the outcomes of:

1. Lead the development, planning, coordination, and implementation of the CEHP & assigned projects in partnership with DOH and Provincial Governments, in line with strategic objectives and internal systems that include accountability and evidence-based outcomes.
2. Directly manage and oversee project implementation and the resolutions of technical/implementation problems to a high-level standard to achieve the desired outcomes.
3. Coordinating key project activities with relevant local and international stakeholders, including the National Committee for Sight Preservation (NCSP), WHO, IAPB and the Advance IPEC project to maximize the projects outcomes and impacts.
4. Develop concept brief, project design document and a pipeline of future projects in line with the Foundation strategy, aligned with the Country Strategy and local need, under the leadership of Country Manager.
5. Undertake advocacy and build relationships with stakeholders, including government officials and other NGOs in line with the objectives of the CEHP and the assigned projects, to contribute to the ending of avoidable blindness in the local context.
6. Manage partner relationships within the agreed governance frameworks of FHF.
7. Collaborate across the FHF Philippine team to develop and maintain strong relationships internally and with all partners.
8. Build capability within the team to drive a culture of engagement and collaboration within The Foundation.
9. Other tasks as requested by your manager.
