- 4. Assisting with the implementation of the recognition and impact program for Mid-Value donors, including donor events, mail outs, handwritten notes, special activities to deepen donor engagement
- Tracking donor communications, actions and feedback in Raiser's Edge/Dynamics
- Working closely with the wider Retention team, Bequest team and Philanthropy team regarding donor movement
- Providing general admin support to the wider Retention and Individual Giving team
